She said the mayors had endorsed the formation of subcommittees to study a program/solution for homelessness in Marin County, as well as sea level rise in our communities. She said their recommendations would be brought to the membership for a vote at the next MCCMC meeting.

Public Comment

Larry Chu and Bob Ravasio spoke as co-chairs of the Twin Cities Coalition for Healthy Youth, an organization that deals with use of alcohol and marijuana by underage juveniles. Recognizing that there is "spillover" between communities, they encouraged each city and town to consistently enforce its Social Host Accountability Ordinance as a way to help address this issue.

Welcome and Introduction of Guests

Mayor Lappert welcomed everyone to the meeting and introduced the members of the Corte Madera Town Council (all present) and Staff —Town Manager Dave Bracken, Director of Administrative Services/Town Treasurer George Warman, Director of Emergency Services Roger Sprehn, Director of Recreation & Leisure Services Mario Fiorentini, and Interim Town Clerk Lisa Harper. He welcomed Central Marin Police Authority members Chief Todd Cusimano and Captain Jim Shirk, who were also in attendance.

The Mayor welcomed guests Gregory Allen and Paula Kirkbride; he noted that Joan Lubamersky, representing Marc Levine's office, had attended the social hour.

Mr. Durst shared his unique wit and humor about life in the Bay Area, Marin County in particular ("the Top 10 Coolest Things about Marin County"), and the national political scene.
